See 50 240 Two-way star interaction

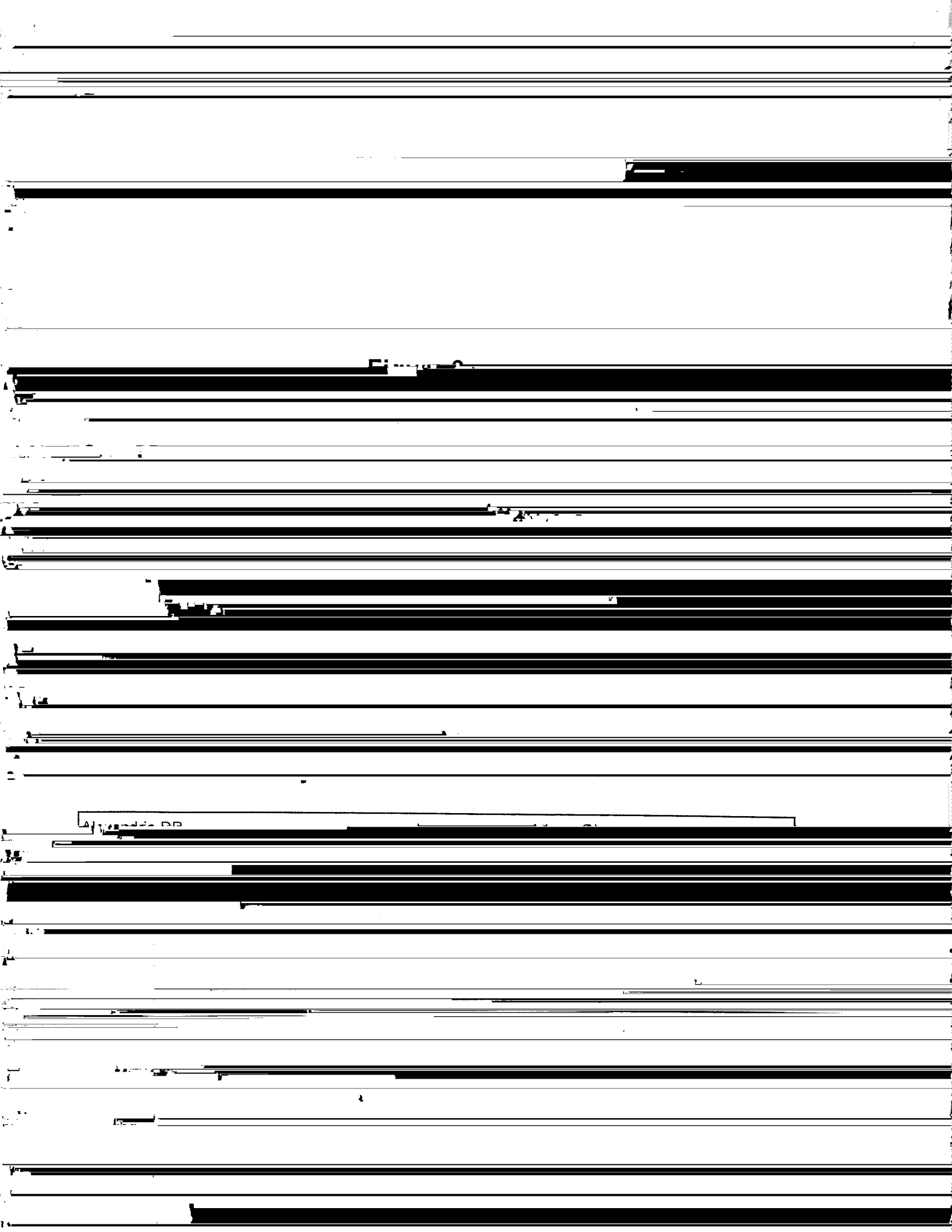

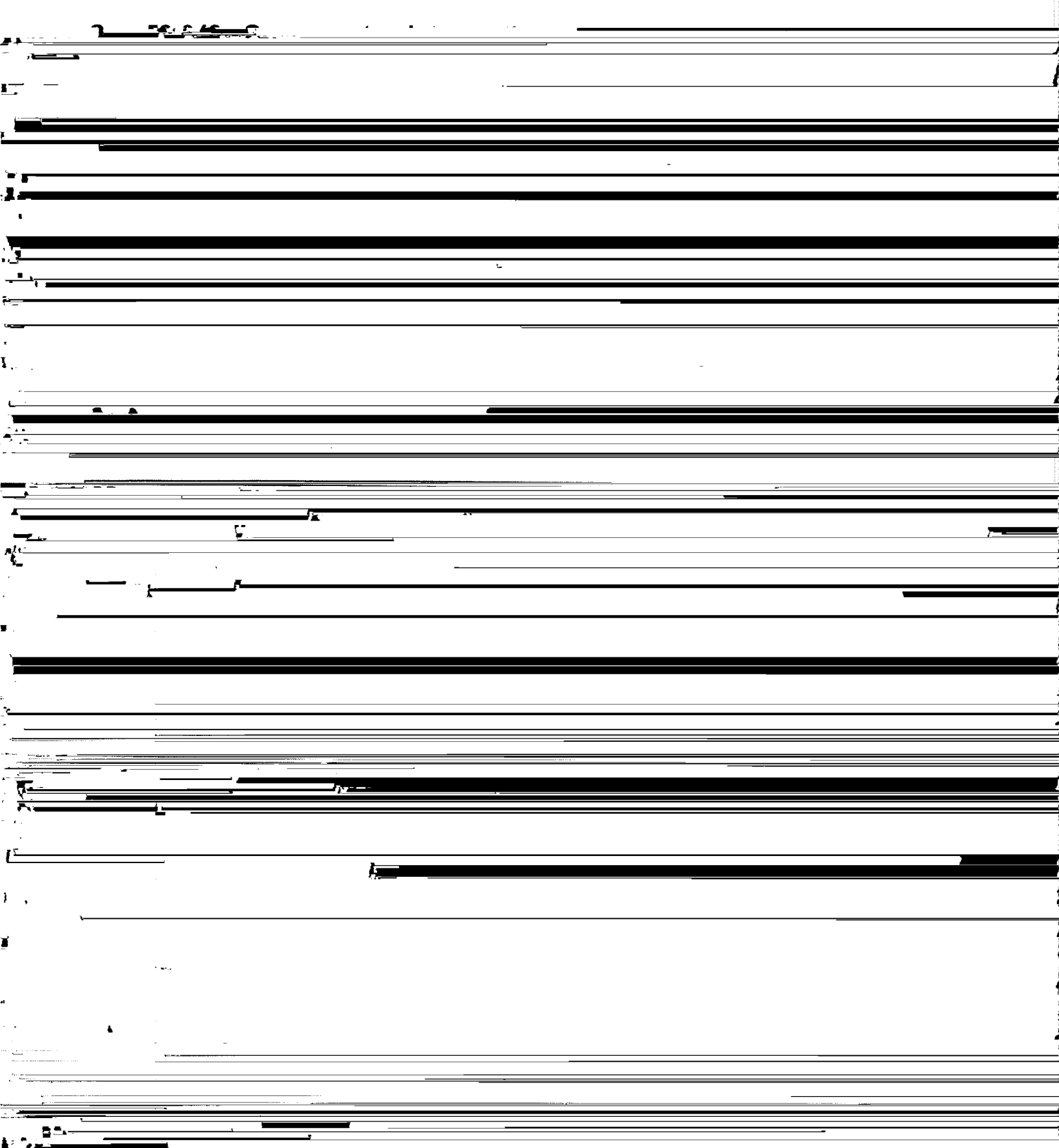

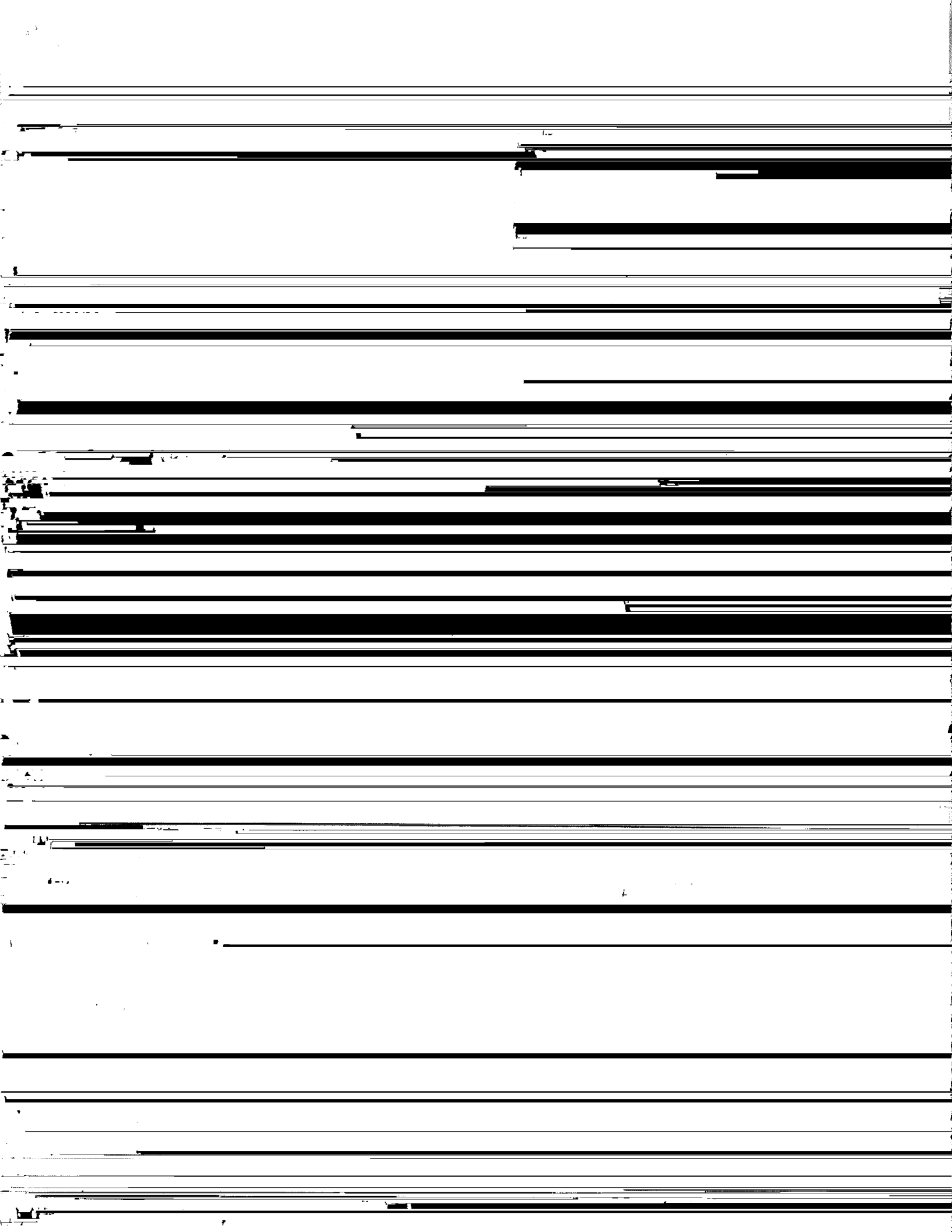

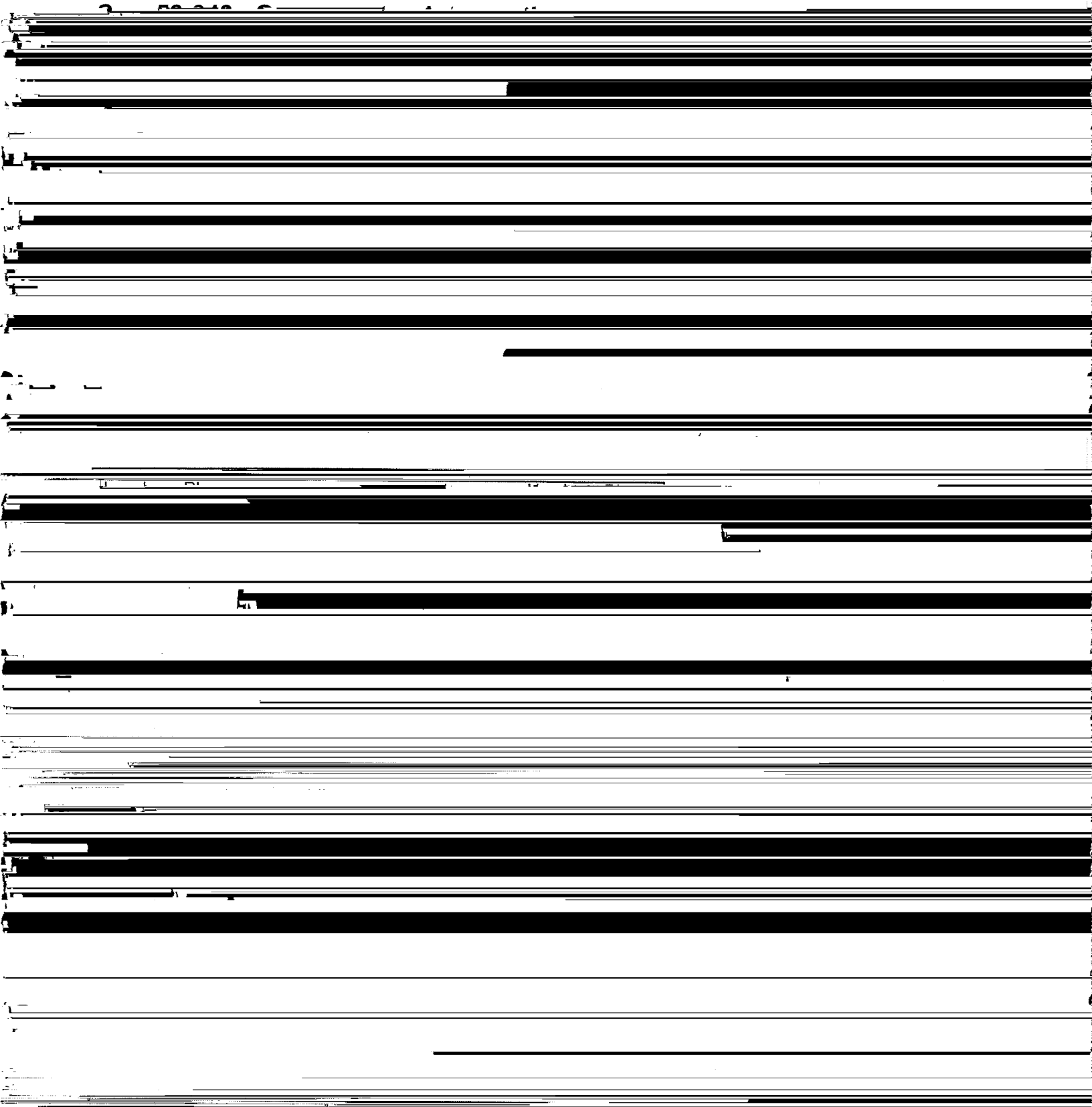

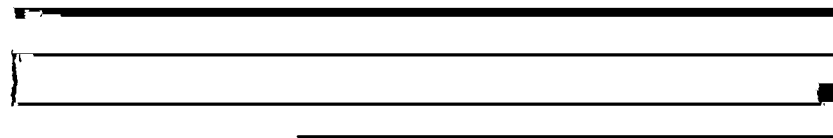

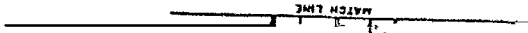
